Terms of office

The Chair is appointed on a three year term by the United Learning Trust.

A Vice-Chair is appointed by the LGB. This is a legal requirement for Academies and should be agreed each Autumn term by the LGB for a one year term or otherwise as agreed with the LGB.

LGB Members are appointed for a three or four year term as agreed by LGB and terms are renewable on an annual basis.

If you have served three terms [nine years] you may wish to consider offering your services to another United Learning school?

Constitution of LGB

The LGB should have a minimum of six, and maximum of fifteen governors

Glebe's LGB has seven governors on their LGB comprised of:

2 x Co-Chairs

1 x Vice Chair

1 x Parent Governor

4 x Co-opted Governors [which includes the Vice Chair]

Staff in Attendance

Karen Crutchfield [Head teacher] Rachel Domagala [School Business Manager] and Steven Williams [Premises Manager] regularly attend LGB meetings.

The Head teacher is entitled to attend all committee meetings

Committee Quorum

Committees are free to determine their own quorum but as a minimum this must be not less than three governor members of the LGB committee present.

Meetings

The LGB will arrange its own cycle of full LGB meetings. The LGB should meet three times (termly) each year as a minimum

Attendance

United Learning wish to remind all LGB members that two consecutive meetings without accepted apologies results in automatic disqualification

Whilst not mandatory, it is also recommended that LGB members carry out Exclusions and Complaints training also so that they may sit on panels if required to do so.

LGB Sub-Committees

The LGB is split into sub-committees which feedback to the LGB on a regular basis.
Each committee should have its own Terms of Reference in place.
